- Regularly assess the person's needs, goals and preferences
- Prepare and review their [Home Care Agreement](#) – including their [individualised budget](#)
- Prepare and review their [care plan](#)
- Ensure their care and services align with other supports
- Partner with the care recipient and their families or carers about their care

- Ensure their care and services are culturally safe
- Identify and address risks to their safety, health and wellbeing.
- Check and monitor on Support Workers
- Make referrals other services when require by consumer

Staff Travel Cost

This is a travel cost for the support worker to visit the consumer's location or accompany consumers to appointments. Support staff travel costs can be billed at \$1 per kilometer.

Self-management clients

Self-management will be different for each participant. The spectrum of activities a participant undertakes will vary depending on the participant's needs, preferences and abilities:

- My Way Support at Home charge is **10% Care management** of quarterly budget; this applies whether the client is fully agency or self-managed.
- My Way Support at Home can also charge self-management overhead cap, where the client sourced directly a third-party contractor or worker, and is self-managed the fund.
- We charge **10% self-managed overhead** of the actual cost of third-party service.
